TIMELINE CONSIDERATIONS

Critical Deadlines

	GST Transfer: Must be completed within 30 days
	EPF/ESI Transfer: Within 60 days of ownership change
T	rade License: Varies by municipality (15-45 days)
□ P	Professional Tax: Within 30 days of transfer
□ P	Pollution Clearances: 45-90 days depending on industry
